# Asiana's Official Change & Refund Policy (Overview)

According to Asiana's Change & Refund policy, you can alter your itinerary, fare basis, or validity under certain conditions. However, the name-change (or name-correction) policy is not always explicitly published in the same place, and rules may depend on fare type, booking class, and origin/destination. Independent sources and airline-policy aggregators report that Asiana allows minor name corrections (typos, small changes) in many cases, sometimes free of charge, whereas full name changes (to a different person) are usually disallowed except for legal name changes supported by documentation.

## Step-by-Step Guide to Correcting a Name on an Asiana Ticket

#### 1. Act Early — Don't Delay

Time is critical. Name corrections are easier to grant earlier in the ticket lifecycle. Try to request corrections as soon as you detect the mistake. Minor corrections may be allowed up to check-in time or up to 24–48 hours before departure. Major changes after check-in or close to departure may be denied.

## 2. Check Whether Your Fare Class Allows Changes

Not all tickets are created equal. Flexible fare classes often allow more flexibility, while basic economy fares may not permit any changes. If you booked through a third-party site, their own policies and fees may apply.

#### 3. Gather Required Documentation

Different types of name corrections call for different supporting documents, such as a passport copy for typos, or a marriage certificate for legal name changes.

### 4. Contact Asiana Customer Support

Call the Asiana support number (for illustration: 1-855-628-4230), or use the Manage Booking section on Asiana's website. Provide your booking reference, correct name, and supporting documents.

## 5. Pay Any Applicable Fee & Reissue Ticket

Depending on fare rules and type of correction, a nominal fee may apply. The corrected ticket will be reissued after verification.

#### 6. Confirm Before Travel

Ensure your ticket name matches your government-issued ID before travel to avoid boarding issues.

#### **Common Scenarios and Best Practices**

Can I change the name after check-in? Usually not. Once the ticket is locked, changes are rarely permitted.

Can I transfer the ticket? No, tickets are non-transferable.

What if I booked through an OTA? Contact your travel agent first, as their own policies may apply.
